

**TOWNSHIP OF O'HARA  
REAL ESTATE TAX REBATE PROGRAM  
TAX REFUND APPLICATION**

On December 10, 2019 O'Hara Township Council adopted Ordinance No. 1359 establishing a real estate tax rebate program. To be eligible for the rebate, the following requirements must be met:

- The Applicant must be a) single and age 60 or older, or b) married, with either the Applicant or the Applicant's spouse being age 60 or older.
- The taxes for which the rebate is sought must relate to the primary personal residence and domicile owned by the Applicant.
- The Applicant must have owned the residence for either a) ten (10) consecutive years or b) five (5) consecutive years if the Applicant received assistance in the acquisition of the property as part of a government or nonprofit housing program.
- The Applicant's 2019 household income (as defined in the Senior Citizen Rebate and Assistance Act at 72 P.S. 4751-3) must be \$30,000 or less.
- 2020 real estate taxes must be paid.

**If requirements are met, the Applicant will receive a rebate in the amount of 25% of the increase in 2020 Township real estate taxes paid over 2019 Township real estate taxes paid.**

To apply for the rebate, a person must complete the application form located on the back of this page and submit it with the required attachments by August 31, 2020 at 4:00 p.m.

After your application has been received by the Township it will be reviewed, and if eligible, you will receive a rebate within 30 - 45 days. If it is determined that you are ineligible for a rebate, you will receive written notice that your application has been denied.

If you file an Assessment Appeal, action on your Township rebate application will be delayed until Allegheny County makes a determination of your appeal.
