

OFFICIAL PROCLAMATION of FIRE PREVENTION WEEK

WHEREAS, the Township of O'Hara is committed to ensuring public safety; and

WHEREAS, the leading cause of home fires involve cooking equipment and unattended cooking; and

WHEREAS, by educating the public about simple but important steps they can take to reduce the risk of fire when cooking will keep themselves and others that are near, safe; and

WHEREAS, the National Fire Protection Association supports "Cooking safety starts with YOU!! Pay attention to fire prevention" and offers the following Cooking Safety Tips:

- Keep a close eye on what you are cooking; set a timer to help monitor what you are cooking or baking;
- Clear the cooking area of any items that can burn, such as dish towels, oven mitts, paper towels, and food packaging;
- Turn pot handles toward the back of the stove;
- Keep a lid nearby when cooking; if a small grease fire starts, slide the lid over the pan and turn the burner off;
- Create a "Kid and Pet-Free Zone" at least three (3) feet around the cooking area and anywhere hot food or drink is prepared or carried;

WHEREAS, by staying in the kitchen, using a timer, and avoiding distractions from what is on the stove will help prevent cooking fires.

WHEREAS, the 2023 Fire Prevention Week theme, ""Cooking safety starts with YOU!! Pay attention to fire prevention" effectively serves to remind everyone to avoid risky kitchen habits to keep our homes and families safe from fire.

NOW, THEREFORE, BE IT RESOLVED, that I, Robert John Smith, President, on behalf of the Township of O'Hara Council, do hereby proclaim October 8 through October 14, 2023 as Fire Prevention Week, and urge all people to pay attention when cooking and to support the many activities and efforts of Township Volunteer Fire and Emergency Services.
