

Where Does the Rain Go?

A watershed is an area of land that drains to a body of water such as a stream, creek, river or lake. Rain or snow that falls anywhere in that watershed eventually flows to that water body. All of us depend on our watershed for the water we use. Some rainfall seeps into the ground and is stored in underground bodies of water called aquifers. Some of the water is soaked up by plants and wetland areas. Water that is not stored in plants or the ground becomes runoff.

The storm drain system is responsible for carrying all stormwater (rain) from your watershed to local streams. The storm drain system is not connected to the wastewater system, which drains water from the plumbing of your home. Storm drains do not send water to a treatment facility where it is cleaned. That means the rainwater and everything it touches – from dirt, motor oil, trash, and pet waste – flows straight into creeks, streams, and local waterways.

This rainwater, or polluted runoff, comes from things we do every day. Anything you dump or drop on the ground adds to polluted runoff. The most common pollutants result from littering. Trash like fast-food wrappers, plastic water bottles, soda cans, plastic cups, foam cups, and even pet waste can end up polluting our local waterways. This pollution can cause damage aquatic animals and plants.

So what are some things you can do to help? Never put anything down storm drains. Do not over fertilize your yard and consider using an organic fertilizer. Fix car leaks of oil and other fluids promptly. Clean up your pet waste. Clean up trash and debris you see.

Each small step we take helps in the fight for clean water. \Box

Coal Tar Sealant Resolution

On May 11, 2021, Township Council unanimously passed Resolution R-38-2021 recommending the use of alternate asphalt seal coating products to the use of coal tar-based products.

Asphalt sealants are used to prolong the life and appearance of asphalt. However, some sealcoats can be as toxic as their pungent aroma. Asphalt sealcoats containing coal tar are a known environmental and health concern. Stopping the use of coal tarbased asphalt sealcoats can reduce the health and environmental dangers these products pose.

Coal tar-based asphalt sealants have environmental effects. They are washed into stormwater runoff from parking lots and driveways. Sealcoats deteriorate into fine particles, which then are swept into storm drains during rain events. The contaminated runoff flows into our streams and rivers. This can be toxic to aquatic life.

The public can be exposed to coal tar-containing sealcoat dust and vapor. Coal tar-based asphalt sealants applied to driveways, parking lots or playgrounds can find its way inside schools and homes, potentially exposing children and adults to toxic carcinogens via skin contact, inhalation or ingestion.

Alternate asphalt sealcoat products provide similar performance and cost about the same, without the negative effects of coal tar.

Most home improvement stores only offer alternate products, so if you are sealing your driveway yourself you should be in good shape. However, if you plan to hire a company to seal a driveway or parking lot, please ensure that they are using an alternate sealing product and not a coal tar-based product.

Being aware of the differences among asphalt sealcoats can help make our community a healthier place for all. \Box

Fall Leaf Collection

The Fall leaf collection program will begin on October 18. The final collection round will begin December 1. This means that once an area is collected after December 1, any leaves placed at the curb will not be picked up.

As in the past, the east and west sections of the Township have been divided into zones. This enables the Public Service Department to follow a set collection route and better communicate with the residents as to where leaf collection is currently being conducted, where it has been done and where it will be done next.

The Township website will be updated daily with this information. Visit *www.ohara.pa.us* and look for the link to Leaf Collection.

Residents are reminded that leaves must be placed within four (4) feet of the curb, *but not in the street*. Leaves left in the street can create a safety hazard, especially if it rains or snows. Ordinance #1273 provides for fines for those who unlawfully and substantially interfere with, obstruct or render dangerous for use or passage any street, road, sidewalk, river or public way or place.

Remember that no other debris may be mixed in with the leaves. Also, placement of obstacles in front of the leaves may hinder collection. A request is made that cars, trash cans or other objects not block access to the leaves. A notice will be left at any home where there is a problem with the collection of leaves. This door hanger will give the reason for the noncollection and give a phone number to call for further collection information.

Solicitation Regulations

The Township regulates "for profit" door-to-door solicitors and requires them to obtain permits. They are given the Do Not Solicit List when their permit is issued. Per Federal law, the Township cannot regulate "non-profit" solicitors. We do ask that when they are in the Township they notify us and follow our Do Not Solicit List.

Residents who do not want solicitors at their home may complete a No Solicitation Request at the Police station or download one at *www.ohara.pa.us* and mail it in or drop it off. This list is given to solicitors and they are not permitted to solicit these homes. Residents may also place a NO SOLICITORS sign on their door or window and solicitors are not permitted to solicit these homes. Please feel free to cut out and post the sign below.

Fall Brush Collection



It may be Summer now, but Fall is not far away. So that you may plan ahead, here is information that may be important to your Fall landscaping plans.

Requests for the Township's Fall brush collection service will be accepted from September 20 to October 1. Requests for collection <u>will not</u> be accepted after 4:30 pm on October 1. However, collection will continue until brush is collected from all residents who have called in requests. Brush <u>will not</u> be collected from homes not on the list.

Residents should call 412-784-1784, ext. 203 to request collection and be prepared to leave their name, address and telephone number.

Requests are for one pick-up only. <u>If additional material</u> is placed at the curb after collection, another request for collection must be made.

Township Brush Collection Regulations

- Limbs and brush must be placed along the curb within 4 feet of the street, *but not in the street*.
- Limbs 4 inches or less in diameter may not exceed 8 feet in length. Limbs 4 to 6 inches in diameter may not exceed 4 feet in length.
- Limbs/logs larger than 6 inches in diameter will not be picked-up.
- Hedges, vines, shrubs and other brush must be separated from tree limbs and securely tied in bundles not to exceed 16 inches in diameter.
- All root balls or dirt must removed. Brush with root balls or dirt attached will not be picked-up.
- Residents are reminded that this is not a tree removal service. Each property is limited to one truckload of brush equal to about six cubic yards.
- Wood chips may be available upon request by calling Loren Kephart, 412-784-1784, ext. 206.

A notice will be left at homes where the brush is not properly prepared for collection explaining why the brush was not collected and will give a phone number to call for further information.

Reminders from the Police

The Township of O'Hara Police Department offers the following reminders to our residents:

Regularly:

- Make sure to always lock your car doors and rollup your car windows.
- Always lock your home doors and windows.
- Consider installing deadbolt locks on all entrance and egress doors.
- Use your porch light at night.
- Consider installing motion sensor lighting in the back of your home.
- If you think you see something suspicious call 911 right away, we are here to serve.

When Travelling:

- Send a vacation check request form into the Police Department to have your home checked daily by an officer. The form is available on our website under documents and forms. The form may be sent via e-mail to <u>info@ohara.pa.us</u>.
- Consider using electronic, digital or manual light timers in your home to switch lights on and off.
- Ask a neighbor to pick up your mail or stop your mail at the post office.
- Try not to have packages delivered to sit outside your home; ask a neighbor to retrieve them or wait to order products until you are home.
- Let friends and family know how to contact you in case there is an emergency with your home.

By following theses simple guidelines, you can help us take a bite out of crime. \Box

Smoke Detector Reminders

Parkview Volunteer Fire Department and EMS and Pleasant Valley Volunteer Fire Company wish to remind all residents about the importance of checking your smoke detector batteries on a regular basis. A smoke detector can save your life. So, plan on checking the batteries of all your smoke detectors on a monthly basis. Also, remember a good time to replace your batteries is every time the clock springs forward and falls back.

A reminder for everyone who has hard-wired smoke alarms with their security systems; Consumer Reports recommends the replacement of all hard-wired detectors every ten years. Hard-wired detectors can begin to deteriorate with age so replacement every ten years is a good rule of thumb.

Let's all have a plan so that if a fire starts everyone gets out safely! \Box

Selling Your Home?

While your real estate agent and closing company will handle many of the matters related to selling your home, there are some things you can do to make the process easier.



Unpaid taxes and municipal fees can hold up your closing. This includes real estate tax, stormwater management fees and earned income tax. If you are not sure if you owe real estate tax or stormwater fees, contact Jordan Tax Services, Inc. at 412-345-7962. For earned income tax information contact Keystone Collections Group at 1-866-539-1100.

Make sure all utility bills (phone, water, sewer, electricity, etc.) are current.

Fox Chapel Authority (412-963-0212) and Hampton Shaler Water Authority (412-486-4867) require backflow prevention devices be installed on all waterlines prior to their final reading. Contact your specific water company for further details.

Township Ordinance No. 1299 requires that a Sanitary Sewer Certificate be obtained prior to the sale or transfer of property.

A Sanitary Sewer Certificate is issued after the Township and a registered plumber perform an inspection verifying that no storm, ground or surface water is directed into the sanitary sewer system.

Property owners arrange and pay for a registered plumber to perform the test. The Township witnesses, inspects and certifies the test at a cost of \$100 for residential buildings and \$200 - \$400 based on square footage for commercial buildings.

It is advisable to have the test done early in the sale process, since repairs **must** be made prior to closing. Once issued, the Certificate is valid for one year from the date of the initial inspection.

Permanent Glass Recycling Site

A permanent glass recycling site in O'Hara Township has been established through a partnership with Aspinwall Borough, Blawnox Borough and the Pennsylvania Resource Council (PRC). Though glass can still be recycled in O'Hara Township's curbside collection, this will most likely not be the case in our next trash and recycling contract.

The glass recycling dumpster is located in the O'Hara Township Building parking lot at 325 Fox Chapel Road, and is available for self-serve drop-off during daylight hours seven days a week from 8 am – Dusk.



Individuals can drop off glass bottles, jars and jugs of all colors (no color sorting required). Containers should be empty and rinsed, with lids and labels still on. Bags and boxes used to deliver glass must be recycled or discarded off-site.

"Glass is still one of the most recyclable materials we generate in our homes, and the market for glass recycling is very strong," according to PRC Recycling Markets Program Manager, Ashley DiGregorio. "It's important from an environmental perspective to keep glass out of landfills. When it's all mixed together, you really don't know if the glass will really ever get recycled, but when it's dropped off at a collection site, you know that 100 percent of it is going to be turned into something new."

"Reasons for recycling glass include the fact that glass can be recycled endlessly and recycling glass requires 70 percent less energy than when manufacturing glass from raw materials," said DiGregorio. "Studies show that 90% of consumers believe glass recycling is important and the success PRC has experienced with its pop-up collections and traveling bin program definitely show that people want to recycle glass whenever possible."
